UACES is a registered charity in England and Wales. Our accounts are in the public domain and can be viewed on the Charities Commission website. Our financial year ends on 30 September each year, and this report covers the period from 1 October 2011 to 30 September 2012 (often abbreviated to 2011-2012). More recent information has been included where relevant to cover the hiatus between the end of the financial year and the Annual General Meeting.

# Message from the Chair

September 2013 marks a full year since the successful UACES annual conference in Passau, Germany. That event, along with the activities that UACES has organised since, reminds us how our Association seeks to balance a number of different aims. We want to be relevant to our international membership by supporting European Studies beyond the UK; and, with an eye on our charitable status in Britain, we routinely involve interested parties beyond academia in our work and its output. The UACES website is a critical tool in marrying these objectives, and has been a focus of much effort earlier this year. Our events and activities, our development and growth: all rely on the ideas, input and goodwill of the UACES committee members alongside the sustained support of our three full-time staff members: Luke Foster, Richard Lewis and Emily Linnemann. I am sincerely grateful to all for ensuring that this first year of my term has gone as smoothly as I could ever have hoped.

Inevitably, the Association is not without its challenges and, in the face of the many factors destabilising the Higher Education environment in the UK, we are taking stock, and calling on our patrons to provide additional inspiration here. The open access publishing agenda; the impact of tuition fees on the shape and size of the HE sector; the knock-on effects on the health of individual institutions, subject disciplines and academic career opportunities: in all these matters and others, UACES is stepping up its dialogue with other subject associations to stay relevant and aware. We are even embarking on a study of the history of UACES: perhaps we can learn something from how our predecessors addressed not entirely dissimilar situations in the past.

We are also, of course, maintaining a busy calendar for the coming year. Thanks to a successful bid to the European Commission's Jean Monnet programme we have funding in 2013-14 to run a project on the Future of Research in/on the EU, expanding on the existing events that we already organise for postgraduate students. The Reporting Europe prize is again being offered to reward exceptional journalism in our subject area, and the deadlines for numerous forms of UACES financial sponsorship close between September and December 2013. The annual conference itself is leaving the UK in 2014 to head to Cork, and in 2015, to Bilbao, Spain, and the call is already open to host the 2016 version of this high point in the UACES annual calendar.

Let me close here by extending my thanks to my colleagues at Leeds University for hosting this year's conference, and by wishing all UACES members a happy and fruitful meeting.

# Membership

Membership of UACES increased to 1250 members as of 30/9/12 (an increase of 6.0% from the previous year). This was comprised of 819 Individual members, 351 Student members and 80 Group members.

Our members are distributed across 52 countries; 36 European countries and 16 countries beyond Europe's borders.

Membership subscriptions will remain unchanged for 2014 (the standard rate of 40 GBP has not increased since 2007).

Student members of the Association benefit from discounted membership subscriptions and for those who do not receive any financial assistance from their own Institutions, there is a travel scheme that provides some financial support to students travelling to selected UACES events.

The Association communicates with its members via the UACES Newsletter and the UACES email list (which has circa 1,200 subscribers\*).

The Association communicates to the public via its website, the EuroResearch email list (with over 1,480 subcribers\*), Twitter and Facebook. Non-members can also subscribe to receive a bi-monthly e-Newsletter.

The UACES website has undergone a major redevelopment over the previous year, with the new design bringing together the various sites in a cohesive way. A notable addition to the site is the UACES archive (www.uaces.org/archive), which brings together various conference papers, audio recordings and other material in one place. The project is ongoing, with further improvements planned for the coming year.


# **Events**

#### Passau 2012

The 2012 Annual Conference took place at the University of Passau, 3-5 September 2012 (www.uaces.org/passau). It was attended by over 400 delegates from 36 different countries, with the biggest contingents being from the UK, Germany (20%), the Netherlands (7%) and Belgium (6%). 
Origin of delegates that attended Passau 2012



## **Officers**

The Officers, through their leadership, are responsible for enabling the UACES Committee and Staff to fulfil their responsibilities in the governance and strategic direction of the Association.

The Officers also have specific responsibilities with regards to the provision of banking services and investments.

## Committee

The Committee is comprised of three elected Officers, six elected Committee members and a number of co-opted Committee members. The Editors of the Journal of Common Market Studies, the Chair of the Standing Conference of Heads of European Studies and the Chair of the UACES Student Forum all sit on the Committee in an ex-officio capacity.

Responsibilities of the Committee include:

- » Encouraging and developing the next generation (including the evaluation and selection of UACES Scholarships)

# **Events and Activities working group**

Convenor: UACES Secretary

The role of the working group is to ensure the success of the Annual Conference and other UACES events, including those organised by the Student Forum.

Other responsibilities of the working group include:

- » Selection of research papers and panels for the Annual Conference

## **Engagement and Internationalisation working group**

Convenor: UACES Chair

The role of the working group is to engage with the European Studies community, the wider community outside the subject area and to develop partnerships with other Associations, policy-makers, and colleagues outside of the UK.

Their role is also to monitor, assess and contribute to broader issues related to changes in higher education that impact upon contemporary European Studies. This currently includes the open access publishing agenda.

Other responsibilities of the working group include:

- » Evaluation, selection and delivery of the UACES Arena seminars
- » Evaluation, selection and oversight of the UACES Collaborative Research Networks
- » Evaluation of potential Re-EUnion events

## Media and Communications working group

Convenor: UACES Chair

The role of the working group is to add value and impact to the existing activities of the Association. They are also responsible for developing media partnerships.

Other responsibilities of the working group include:

- » Oversight of the UACES websites and electronic communications
- » The Reporting Europe, the Best Book and Best PhD prizes (the judging for these prizes is delegated to specially convened juries)

#### **Investment working group**

Convenor: UACES Treasurer

The working group has specific responsibility, delegated to it by the Officers, for the UACES Investment portfolio (known as Fund C). The group also provides advice to the Officers on the funds held as cash deposits and bonds (known as Fund A and Fund B).

# **Summary Accounts**

In line with Charity Commission requirements, the accounts for 2011-2012 have been independently examined.

Important to note, in addition to the figures below, is that UACES has a cessation liability with regards to the pension scheme with the London Pension Fund Authority. The indicative cessation deficit for UACES, payable by lump sum when the last active member leaves the scheme iss £229,000 as of 29 November 2012.
