INTERSECT: Technology-Security-Society interplays in Europe

Call for Papers: INTERSECT will be holding its final workshop on 6-7 February, 2020 at the University of Amsterdam. It will address the topic **'The Future of EU Security: issues, concepts and approaches.'**

The workshop will be organised in cooperation with the FOLLOW project, the University of Amsterdam Center for European Studies (ACES), and the Vrije Universiteit Amsterdam's Interdisciplinary Centre for European Studies (VICES) and its main objective is to advance on a future research agenda for EU security that will unfold within the triangle of INTERSECT, i.e. within the mutual influences between technology developments, security practices, and societal change. The secondary objective is to foster dialogue between researchers, practitioners, students, and the general public.

The workshop welcomes theoretical reflections and empirical studies on the developments in three topics:

- artificial intelligence and predictive analytics in security and war
- · financial security and the shrinking civil society space
- Interplays between communities of research and practice in EU security

This call for papers is open to PhD students and early career academics. We invite submissions addressing one of these three themes. Submissions should include a 300-word abstract as a well as a short bio of the paper author(s). The submissions should be sent to Bruno Oliveira Martins (brumar@prio.org).

A small travel stipend will be available for PhD candidates that need travel support.

The deadline for submissions is 10 December 2019.

Communicating Europe

On 19th-20th September 2019, Communicating Europe held a workshop 'Discourses on the European Union in Times of Political Change'. This workshop brought together European Studies scholars from a range of disciplines including law, political science, international relations and communications, from PhD students beginning their careers to established professors. With a keynote by Professor Laura Cram from Edinburgh on neuroscience and identity, the papers presented throughout the two days covered issues such as the Commission's engagement with and incorporation of populist discourses, how the Member States communicate decisions taken by the Council of the EU, the role of anger and emotion in communicating about EU-related issues,

and the rise of populist Euroscepticism in contemporary politics. The papers will be developed into a possible special issue or edited volume.

Differentiated Integration in the European Union after 'Brexit'

At a time when the EU and the UK seem to be closing in on the finishing line of – what we assume to be just the first phase of – a presumably long and cumbersome 'Brexiting' process, the RN network on 'Differentiated Integration" has been launching a call for its final conference to be held at the University of Agder, April 29 and 30, 2020. We have received an exceptionally high number of abstracts documenting the huge interest in the topic. In addition to funding from UACES, the University of Agder and the Jean Monnet Chair are going to support the event that will bring together around 30 scholars next spring. The conference contributions are expected to contribute towards a Handbook on Differentiation in European Integration under contract with Routledge.
