
# **Doctoral Training Academy**

The event is funded by the Erasmus+ Programme of the European Union.







# Did you know that the Ideas on Europe column on eu!radio went into a new round this season?

### We are calling for contributions!

Just drop an idea of a topic to UACES Member Albrecht Sonntag (albrecht.sonntag@essca.fr), who serves as liaison on this project. Once a calendar slot is agreed upon, what is required is a 600-650-word script for a four-minute editorial that speaks about research findings in a way that is suitable for a broader public with a keen European interest. The columns are in English, but most of the public are non-native speakers. And Albrecht, who has himself produced some 130 such editorials over the last years, will assist in editing the final text. Recording is extremely easy – just like in an online talk on your computer.


